IPSE 2.5 May Report - C.P. Wadsworth, 4th June 1986

#### 1. Overview

Technical work during May has been dominated by revision of the Formal Reasoning concepts paper (FRcp) and further discussions with project staff at MU. Recruitment of two RAs to the project at RAL is proceeding. Offers of appointment and signature of the Collaboration Agreement cannot be done until RAL grant is officially announced.

## Staffing

Chris Wadsworth is the one person on the project at RAL to date, approximately 80% during May. Start date for Brian Ritchie is confirmed as 1/8/86. Advertisements for two RAs appeared in the press during May. Closing date for applications is 6/6/86. Interviews will be held after CPW returns from leave.
